On February 21, 2020, the State Council issued the "Guidelines for the Prevention and Control Measures for Enterprise s and Institutions Resuming Production and Resuming Outbreaks" in response to the joint prevention and control mechanis m for new coronavirus infection pneumonia It has played an active role in guiding enterprises and institutions to do epidemic prevention and control work, and steadily and orderly resume work and production. At present, the national epidemic preven tion and control situation continues to improve. The vast majority of counties (cities, districts, and flags) are already low-risk areas, and it is necessary to use the provincial territory as a unit to promote the restoration of economic and social order. In order to further promote the comprehensive resumption of production and production of enterprises and institutions in low-risk areas of the country, restore normal production and living order as soon as possible, and promote high-risk and medium-risk areas to continue to do a good job of enterprises and institutions in accordance with relevant requirements such as scient ific prevention and control, precise implementation of policies, and regional classification The unit's epidemic prevention and control work and the resumption of production and work resumed in an orderly way to restore production and living order. With the approval of the Central Leading Group for Response to the New Coronavirus Infection Pneumonia Outbreak, the "Guidelines for the Prevention and Control Measures for the Resumption of Production and Resumption of Production in Enterprises and Institutions in Different Risk Areas of the Country" Printed and distributed to you, please implement it according to the actual situation.

Guidance on prevention and control measures for enterprises and institutions in different risk areas to resume work and resume production

In order to further promote the comprehensive resumption of production and production of enterprises and institutions in low-risk areas of the country, restore normal production and living order as soon as possible, and promote high-risk and med ium-risk areas to continue to do a good job of enterprises and institutions in accordance with relevant requirements such as scientific prevention and control, precise implementation of policies, and regional classification. The prevention and control of the epidemic situation of the unit and the resumption of production and production work in order to restore the order of production and life in order to formulate this guideline for prevention and control measures.

- 1. Enterprises and institutions in low-risk areas
- (1) All units should implement foreign defense import strategies, timely grasp the flow of employees, and conduct health management for personnel from high-risk, medium-risk areas and overseas in accordance with the requirements of the region

n; Personnel in low-risk areas can go to work if the body temperature test is normal, no barriers should be set up, and no pre -job isolation can be implemented.

- (2) All units should keep abreast of the staff's physical condition and find out that the staff have fever and respiratory sy mptoms, and arrange to go to the designated hospital for medical treatment as soon as possible. Once a suspected or confir med case is found, it must immediately initiate a response to the plan and properly handle it.
  - (3) All units should maintain ventilation in the workplace, and natural ventilation is preferred when conditions permit.
- (4) All units shall set up hand-washing facilities in the workplace or equip them with disposable disinfection supplies, an d pay attention to the cleaning and disinfection of work and living places.
- (5) During the epidemic prevention period, each unit should minimize the gathering of people and collective activities, m aintain the air circulation in the indoor gathering place, strengthen the management of employees' meals, and clean and disinfect the tableware in the canteen.
- (6) Under the premise of adopting effective measures to ensure the air circulation and cleaning and disinfection of the e mployees' collective dormitory, each unit independently decides the number of personnel arranged in each dormitory.
- (7) All units should do a good job in popularizing knowledge on epidemic prevention and control, guide and urge employees to enhance protection awareness, implement personal protection requirements, develop hand washing habits, and cover wh en sneezing or coughing. (8) Employees engaged in hazardous operations related to exposure to dust, chemical poison s, etc. should wear masks in accordance with occupational health regulations and other relevant requirements. Other emplo yees may wear masks in accordance with the "Guidelines for Wearing Scientific Masks by the Public". Decide. (9) All un its must guarantee emergency response capabilities, and realize early detection, early reporting, early isolation, early treatm ent of asymptomatic infected persons, suspected and confirmed cases, and prevention of cluster epidemics.

## 2. High- and medium-risk areas enterprises and institutions

High- and medium-risk areas, based on the implementation of low-risk areas enterprises and institutions prevention and control measures, should strengthen employee health monitoring and entry and exit registration management, employees a nd outsiders enter the unit Or conduct body temperature testing before the factory, and then enter normally; implement work place prevention and control measures to reduce the number of meetings held, shorten the time and control the meetings th at need to be held, and promote the holding of video or telephone conferences, and take the wrong time to work and flexibilit y according to actual conditions Work system or home office method; guide employees to do personal protection, minimize going out, especially to avoid crowds or places with poor air mobility; clarify epidemic prevention and control emergency mea sures and disposal processes, and implement prevention and control responsibilities to departments and individuals, Handle abnormal situations properly. The specific prevention and control measures shall continue to be implemented in accordance with the requirements of the "Notice of the State Council on the Joint Prevention and Control of New Coronavirus Infection P neumonia Joint Control Mechanism on Printing and Distributing the Guidelines for the Prevention and Control Measures for Enterprises and Institutions Resuming Production and Resuming Production"

## 3. Relevant work requirements The
